Report Title: Sunshine Law; Board Meetings; Notice of Board Meetings

Description: Permits use of interactive conference technology to increase ability of members of state and county boards and commissions to attend board meetings; allows a board member with a disability that limits or impairs the member's ability to physically attend the meeting to participate in a board meeting from a location not accessible to the public if connected by both visual and audio means. (CD1)
