Measure Title: RELATING TO PUBLIC AGENCY MEETINGS.

Report Title: Public Attendance; Agency Meetings

Description: Allows boards and commissions to conduct on-site inspections of locations related to board or commission business that are closed to the public, if public attendance is impracticable. Requires the director of the office of information practices to act in certain instances instead of the attorney general. (SB3105 SD1)
