

OIP FORMAL OPINION LETTERS

Prior to July 2012, OIP numbered and grouped its formal opinions by calendar year on its website. To be consistent with its reporting by fiscal year for its budget and annual reports, OIP's formal and informal opinions are now grouped by fiscal years, which begin on July 1 and end on June 30. FY 1990 began on July 1, 1989 and ended on June 30, 1990.

Formal opinions before July 2012 will continue to be referred to by their existing opinion letter numbers, which began with the last two digits of the calendar, not fiscal, year in which they were issued. Beginning in FY 2013, which runs from July 1, 2012 until June 30, 2013, formal opinion numbers will start with "F," followed by the last two digits of the fiscal year in which the opinion was issued. For example, the first formal opinion in FY 2013 will be "F13-01."
